## **Objectives for Real Sector Statistics**

The objectives of the AFRITAC West 2 (AW2) Real Sector Statistics Program are to **build institutional capacity**, **promote regional harmonization**, and **improve the quality of the national accounts and prices statistics** through the adoption of good practices and the latest international standards.

## **About AFRITAC West 2**

AW2 **commenced operations in January 2014.** It is a collaborative effort between the International Monetary Fund (IMF) and several bilateral and multilateral partners aimed at **providing technical advice** in core macroeconomic and financial management areas.

It provides Technical Assistance (TA) and training to **Cabo Verde, Ghana, Liberia, Nigeria, Sierra Leone and The Gambia**.

It works closely with the IMF's African Department mission teams.


# Significant Challenge During the AW2 Phase I Program (2014–2017)

The first eighteen months of AFW2's operations were challenging because of the impact of the **Ebola Virus Disease** (EVD). This affected both **Liberia and Sierra Leone**.

In response, AW2 provided **remote TA to Liberia** by reviewing and improving the methodology for the ongoing GDP estimation following the rebasing of the national accounts.

# Main Achievements During the AW2 Phase I Program (2014–2017)

Through its Accra-based AW2, the IMF has provided **126 person-weeks** of technical assistance (TA) and training on real sector statistics to six member states during 2014–2017.



- 5 of the 6 member states are producing and disseminating annual GDP by economic activity (GDP-P) and GDP by expenditure (GDP-E) estimates at both current and constant prices.
- **Liberia** has started compiling GDP estimates but is yet to disseminate.
- **Nigeria and The Gambia** completed the rebase of their GDP estimates during the period.
- **Ghana, Nigeria and The Gambia** have rebased their consumer price index (CPI).
- **Liberia** has rebased their consumer price index (CPI) using their country specific data for the first time.

# **Improving Annual GDP**

### All of the member states are now:

- Updating their base years ranging from 2013 to 2018.
- Implementing the relevant 2008 SNA changes.
- Improving access to and the quality of administrative data and surveys.

**Nigeria** is developing a new survey in order to estimate private consumption for GDP-E independently.

Most member states are looking to developing well maintained **business registers** in the coming year.

# **Developing Quarterly GDP**

**Ghana, Nigeria and Cabo Verde** publish quarterly GDP-P and are currently developing GDP-E estimates.

During the next five years, it is expected that **The Gambia** will commence publishing quarterly GDP.

# **Expanding and Improving Price Statistics**

**Most member states** are conducting, or planning to conduct, **household income and expenditure surveys** during 2017 to 2020 in order to rebase their CPI.

**Most member states** are developing, improving and rebasing the **producer price index (PPI)**.

## **Regional Integration and TA Coordination**

The Real Sector Statistics advisor and Fiscal Affairs advisors work collaboratively in AW2 to maximize the benefit of TA provided and to address potential areas of intersectoral overlap.

AW2 and the IMF continue to support regional initiatives, including:

- Supporting the harmonization and integration objectives of Economic Community of West African States (ECOWAS)
- Conducting regional workshops with other regional ٠ development partners.

AW2 will continue to work closely with other TA providers in the region, especially the second Enhanced Data Dissemination Initiative (EDDI2), a Department for International Development of the UK funded initiative.
